# **Executive Summary**

Multnomah County provides facilities for the operations of the state courts. These facilities include jury rooms, court rooms, offices, and court records storage. This program offer will renew a lease and increase the amount of the State Courts' records storage space for the next three years.

#### **Program Description**

The Facilities organization provides services ranging from planning, construction, operations and maintenance, to cleaning the buildings and grounds for courtrooms located in Multnomah County's owned and leased facilities.

## **Program Justification**

County-provided courtroom space is a key resource in the County's justice system. Multnomah County courts' central locations allow easy access to the court system, provide visibility to the community of the safety system at work, and allow the justice system to hold offenders accountable.

## **Legal/Contractual Obligation**

ORS 1.185 reads " County to provide courtrooms, offices, and jury rooms. (1) The County in which a circuit court is located or holds court shall: (a) provide suitable and sufficient courtrooms, offices, and jury rooms for the court, the judges, other officers, and employees of the court and juries in attendance upon the court, and provide maintenance and utilities for those courtrooms, offices, and jury rooms. (b) Pay expenses of the court in the county other than those expenses required by law to be paid by the state. (2) Except as provided in subsection (1) of this section, all supplies, materials, equipment, and other property necessary for the operation of the circuit courts shall be provided by the state under ORS 1.185. [Formerly 1.165]"
