Executive Summary

Children's Assessment Services (CAS) provides comprehensive physical exams for children who, due to abuse or neglect, are in custody of the state. CAS also provides services to children residing at the Children's Receiving Center (CRC). Most clients are under 5 years old; eligibility continues to age 18. Many of the children have had no recent medical or dental care and suffer from untreated medical problems. CAS provides support, coordination and intervention to some of our county's most vulnerable members.

Program Description

Children in DHS custody are referred to CAS for a comprehensive medical exam. Oregon Health Plan is available to children in standard foster care; children in relative custody often do not have health care coverage. A summary of findings and concerns is shared with DHS and the child's primary care medical provider. The foster parent receives a visit summary documenting recommend referrals and resources. Services are coordinated with the Children's Receiving Center (CRC); staff provides assessment for children in CRC care within 24 hours of admission. Children with concerns of sexual abuse are referred to CARES NW for a complete forensic exam. Education and resources are provided to caretakers; referrals are made to Morrison Center for mental health evaluation and treatment, children 0-3 years of age are referred to Early Intervention for developmental concerns (social, behavioral or emotional), and referrals are made to other services as needs indicate. By identifying and addressing health concerns early, long-term problems can often be prevented. Prevention or early treatment of health problems reduces long-term health care costs and supports children's development into productive adults.

Program Justification

CAS provides safety net services for children suffering from abuse or neglect. Comprehensive examination is the basis for referral to needed services. CAS is unique in its focus on collection of medical history for children in foster care and coordination of care with community partners. Care providers receive education including a take-home "to-do" list and children are referred to needed resources. Medical evaluation, coordination of services with CRC and CARES NW, and communication with DHS are distinguishing program features. CAS addresses Basic Living Needs strategies related to the provision of access to care and services for this vulnerable population.
