**Executive Summary**

The Pre-Trial Supervision Program (PSP) performs functions critical to the effective operation of our local criminal justice system and public safety by re-assessing (at the request of the courts) the flight and safety risk posed by incarcerated defendants, and supervising those defendants who are released from jail prior to trial. PSP is effective: 87% of defendants appear at their first hearing. PSP supervises more than 1,200 defendants annually, including those previously supervised by the Sheriff's Office Close Street Supervision Program, averting an estimated \$15,840,000 in potential jail bed costs. In October 2005, PSP also began supervising defendants "matrixed" from the jail due to an over-fill of inmates. Figures for this new Matrix component show 572 defendants supervised in the past three months.

**Program Description**

PSP has two primary goals: 1) community safety and 2) ensuring that defendants attend all court hearings. PSP case managers and officers respond to court orders requesting that defendants be released to community supervision pending trial, if appropriate. They complete an investigation and notify the court of their decision to accept or deny the defendant for supervision. Their decision is based on indicators which predict whether the defendant will appear at court hearings and remain crime-free in the community. Once a defendant is accepted for supervision, the PSP case managers and officers conduct on-going home and office visits to assess the defendant's stability and behavior. PSP supervision allows defendants the opportunity to remain employed, attend school, continue health care services (drug/alcohol/mental health treatment), and live at home prior to trial.

**Program Justification**

PSP contributes to community safety by establishing a consistent system of assessing and supervising pre-trial felony and misdemeanor defendants. By saving jail beds where appropriate, it averts an estimated \$15,840,000 in potential jail bed utilization, and frees jail space to hold higher risk offenders. Assessment and case management practices consider victim needs as well as the defendant's risk to re-offend. This unit manages cases via methods which have proved to be effective in lowering criminal activity (Andrews, 1994).

**Legal/Contractual Obligation**

Pretrial Release Services became statutory under Oregon Revised Statutes, 135.230 and 135.260 in January 1974. ORS 135.245 requires a judge to impose the least restrictive condition necessary to ensure a defendant's later court appearance and to release persons in custody on their own recognizance unless conditions indicate such release is unwarranted.
