**Executive Summary**

The adult Community Service Program (CS) annually assists more than 1,150 offenders in meeting court-mandated obligations to perform community work. Offenders work in parks, assist non-profit agencies, and help with community clean up projects, resulting this past year in 45,798 hours of unpaid community service.

**Program Description**

Community Service provides the courts and parole/probation officers (PPOs) with a cost-effective method of holding offenders accountable, allowing them to pay their obligation to the community through unpaid work. Judges sentence offenders to community service as a condition of probation, and PPOs can order offenders to complete community service as a consequence of a supervision violation. CS sends work crews to parks to perform routine maintenance, and 108 non-profit community organizations use offenders for non-paid work. Specialized work crews help offenders with physical disabilities and mental health issues meet their obligations as well. For appropriate offenders, this is a much less costly consequence than jail.

**Program Justification**

CS links to Safety priorities by providing the courts and PPOs with a productive and low cost alternative to incarceration while allowing offenders the chance to repair harm to the community (restorative justice). Last year, offenders performed 45,798 hours of community service, the equivalent of \$343,485 of labor. Those same hours saved the equivalent of 2,862 jail bed days or \$314,820 in annual jail costs. By using CS as a sanction over jail, jail space is available for more dangerous criminals while the livability of the community is increased through offender volunteer services. This is in line with the "Streams of Offenders" model. Offenders are held accountable.

### Explanation of Revenues

The program is funded by state Department of Corrections \$569,709; county general fund \$45,344; City of Portland Parks Bureau \$111,618 and Water Bureau \$40,000 for offender work crews to maintain Portland Parks and Water Bureau sites. The work crews are coordinated and supervised by Community Service Program.
