Executive Summary

FREDs Division Management leads, coordinates, and administratively supports the delivery of the division's operational support services, (Fleet, Records, Electronics, Distribution, and Materiel Management) to County programs and other government agencies.

Program Description

FREDs Division Management administers the division's programs and provides personnel management, budget preparation and control, capital purchasing, billing services, policy development, customer relations, problem resolution, quality control, financial management, internal controls, and other administrative functions. The program provides detailed billings and service usage information to departments to help them effectively manage their demand for FREDs' services and overall County costs.

Program Justification

FREDs Division Management supports Accountability's primary factor of Resource Management through the strategy of "Manage resources and service delivery costs effectively".

- FREDs Division Management leads and supports the division's operational sections in working with County programs to: right-size the fleet and motor pools; effectively utilize central stores services to reduce departmental transactional efforts; and work with departments to better understand how best to utilize FREDs' support services to meet their service delivery needs.
- It supports effective service delivery costs by providing the Division's operational programs with the appropriate amount of administrative, fiscal, managerial, and, in the case of Electronic Services, supervisory support. This support allows FREDs' operational sections to focus on meeting their customers' direct service needs with staffing levels that are as low as practical.
- FREDs Division Management continuously works with the sections in sharing staff, shifting workloads, and changing processes to generate synergies that produce results greater than the capabilities of the individual sections.
- FREDs' sections share assets and skills by providing services to over 70 non-County agencies. FREDs Division Management helps the sections generate \$1,047,500 (FY05 Actual) in outside revenue which lowers overall service delivery costs and provides the community with "more bang for the local buck".
- FREDs standardized service and charge descriptions and service level agreements between sections, as well as standardized countywide processes (administrative procedures, mail pickup/delivery, Central Stores ordering, motor pool reservations, repair requests, vehicle logos etc.), which supports the Accountability strategy of more uniform county administrative practices and operational culture.
