## **Executive Summary**

The Children's Receiving Center, located on the Gateway Children's Campus, is an emergency shelter for four-to-11 –year-old children removed from their home due to alleged abuse or neglect. The program provides holistic services to a vulnerable and needy population. Evaluations to date demonstrate this service's effectiveness in reducing the number of subsequent foster care placements for children. Planning for service continuation is needed, as funding through a five-year State revenue agreement ends March 2007.

### **Program Description**

The Children's Receiving Center, operating 24 hours a day, seven days a week, provides short-term shelter, food, clothing, and other appropriate services to children who have been removed from their own home or prior foster/relative care placement because of allegations of abuse, neglect or other reasons. Additional admissions include children in need of respite from their foster or relative care placement and those in need of placement planning after a failed placement. This program model supports a variety of best practices in foster care. It works particularly well for children who are new to foster care or who are part of sibling groups. This service is a cooperative effort, leveraging the resources of: Multnomah County, the City of Portland, the District Attorney, Law Enforcement Agencies, the Gateway Community Association, the Christie School, and the Oregon Department of Human Services.

### **Program Justification**

The program seeks to make available a safe nurturing environment to child victims of alleged abuse and/or neglect. The facility based services meet the Basic Living Needs Priority as a crisis service that intervenes in preventing further behavioral deterioration of vulnerable children, that could lead to assault, victimization or other serious consequences. Services are provided in a family centered, culturally appropriate way that strengthens supports for the children and their families. The program provides comprehensive community supports and services and is specifically designed to provide immediate support for police and law enforcement officials that need emergency placement for children taken into custody. The program links to the Early Childhood Framework by reducing the incidence of alleged abuse and neglect.

## **Performance Measure - Description**

Children Discharged: The number of children served by the Children's Receiving Center.

Sibling Groups Discharging Together: 60% of children served are admitted with siblings. A foster care best practice is to keep these sibling groups intact. This measures the program's ability to place these sibling groups together.

Out of Home Placements: This is a measure of the effect on a child's stability beyond the time (average 5 days) spent in care. Through 2004, children discharging from the Children's Receiving Center averaged 2.65 placements compared to a control group's average of 3.99 placements. By eliminating the brief placement at the center, the average drops to 1.65 average placements for children served at the Children's Receiving Center.
