#### **Executive Summary**

The County's managed Mental Health Organization, Verity, pays a 5.8% provider tax to the State to leverage additional federal funds for the Oregon Health Plan. The additional funds received by the State are then redistributed through the Oregon Health Plan reimbursement.

#### **Program Description**

The Oregon State Legislature approved a tax on managed care plans to support benefits for Oregon Health Plan Standard enrollees. The dollars raised by the tax on managed care plans are eligible to be matched by federal Medicaid funds. The federal government will match every dollar the State raises with \$1.50. This additional money is used by the State to fund Oregon Health Plan benefits so that individuals at a higher percentage of the federal poverty level can receive health care, including mental health.

### **Program Justification**

The Provider Tax links to the Basic Living Needs priority as well as the Poverty Elimination Framework by providing access to care for more people in need. Without insurance to cover outpatient mental health treatment, mentally ill individuals are more likely to experience a psychiatric crisis requiring them to be hospitalized. The provider tax helps ensure additional residents and prevents the use of more expensive levels of care, such as hospitalization, by making outpatient treatment available for those who require it.
