Executive Summary

Vectors transmit communicable disease from animals to humans. Vector and Nuisance Control protects the health, safety and livability of our community by surveying and controlling rodent and mosquito populations, enforcing nuisance codes, and educating the public to prevent public health vector problems. Program prepared for and responds to emerging diseases including avian influenza and other vector borne diseases such as West Nile Virus and Hanta virus.

Program Description

Vector Surveillance - collecting and identifying vector organisms (mosquitoes, birds, rats) to determine their species, types of disease(s) they carry, their preferred breeding habitat, and their population size in order to monitor and control their population numbers to reduce the risk of vector-borne disease. Mosquito Control - education, reduction of mosquito-breeding locations and application of naturally occuring organic pesticides to water collection structures (catch basins), floodplains, sloughs, or any area where mosquitoes are found. Work is critical to reduce the population and their ability to breed to minimize risk of disease. Rodent Control - education, reduction of rat attractants like foods and shelter and application of rodenticides to any area where rats are present to reduce the population to minimize risk of disease such as Plague and Hantavirus. Nuisance Control - code enforcement process to eliminate any condition or practice that would cause an unreasonable threat to the public health, safety and welfare of our community; includes solid waste, illegal dumping, specified animals (e.g., bees, livestock, exotic animals) and sanitation regulation and monitoring.

Program Justification

This program addresses the Basic Needs strategy of preventing and controlling the spread of communicable disease through education and effective mosquito and rat control, as well as reducing housing environmental hazards through Nuisance Code enforcement.

Rodent inspections conducted: On-site inspections stemming from rodent complaints received.
