Executive Summary

Regional Health System Emergency Preparedness is a 6-county planning partnership that focuses on preparing private health care providers to care for victims of large-scale emergencies. (In contrast, the Public Health Emergency Preparedness Program focuses on preparing the Health Department to carry out its unique governmental responsibilities in emergencies.) The Regional Health System Emergency Preparedness Program directly supports the Communities factor in the Safety Priority.

Program Description

The Regional Health System Emergency Preparedness program coordinates health care emergency preparedness in NW Oregon (Multnomah, Clackamas, Washington, Columbia, Tillamook and Clatsop Counties). The program provides staffing to convene stakeholders and facilitate and monitor development of a coordinated health care system response to major public health emergencies. The program creates regional plans to 1) temporarily increase the number of patients that hospitals and other health care providers (private doctors' offices, community clinics, behavioral health providers) can care for ("surge capacity"); 2) develops systems for communicating with culturally specific populations; and 3) improves health care providers' ability to communicate with each other in an emergency. These plans guide distribution of \$6.5-8M in Federal Health Resources and Services Administration (HRSA) funds to hospitals and other providers during 2002-07. The program oversees 52 contracts with hospitals and community/professional organizations to develop regional health care response plans, train providers and affiliated staff on the plans, and conduct exercises to test the plans.

Program Justification

The Regional Health System Emergency Preparedness program directly supports the Communities factor in the Safety Priority. Specifically, the program supports the strategy to "Prepare, prevent, and respond to emergencies."
