Executive Summary

Early Childhood Services services more than 2,800 clients in this portion of the scaled offer, providing home visits to families with young children to promote healthy child development. Priority clients are those at most risk of not achieving healthy early child development. ECS strategies are based on county's early childhood framework. Since the early '90's, ECS has used "Children ready to learn by Kindergarten" as an organizing principle for their services.

Program Description

Nurses & community health workers provide home visits focusing on prevention, risk reduction, early identification of problems (screening), & linkage to community resources. Services include health education, screening for health & development, nutrition education, parent education on child development, age appropriate stimulation, nurturing & discipline. ECS contracts with community partners for education & support to specific populations. For families not seen during pregnancy, services begin soon after birth & continue through infancy to help parents meet their infant's basic health & developmental needs. First time & teen parents are seen at time of delivery at the hospital for a Welcome Baby visit. This offer targets high risk infants (low birth weight, premature, known medical conditions) & infants without known health problems whose parents may not be able to fully support their growth & development such as teen parents, first-time parents, parents with mental health problems, cognitively delayed, or parent with addictions.

Program Justification

To assure an infant is ready to learn at kindergarten they need parents prepared to support their growth & development including physical & social-emotional development; and experiences that promote healthy child development. ECS has a range of services customized to serve clients, such as Babies First a statewide high-risk infant monitoring & follow up program, which provides developmental screenings, referral for services, health education, & coordinated care with other agencies. CaCoon provides care coordination, referral, & parent education for children with known medical problems. State Healthy Start provides home-based services to families focusing on meeting basic needs & parent education. This offer supports strategies 1 & 2 of the Education team. We work with parents to ensure the basic needs of their children are met by providing direct services to impact physical & mental health & linking to community resources to meet basic needs. Providing parents appropriate health & development education prepares & supports parents' ability to meet their child's health & developmental needs.
