Executive Summary

In 2003, 73% of the men and 85% of the women booked into the Multnomah County jail tested positive for drugs. Drug diversion (STOP Drug Court) contributes to public safety by providing outpatient treatment and supervision to nearly 450 adult offenders each year. It is part of the continuum of treatment that contributes to an effective Public Safety system. The STOP Drug Court holds those adults charged with illegal drug offenses accountable while providing them opportunity for treatment. Those who successfully complete treatment and the conditions of the court are not convicted of their charge. Drug diversion links directly to Safety priorities by providing drug treatment assistance, collaborating with public and community agencies to use county resources wisely, and holding people accountable for their actions. The program works: Independent studies show drug diversion (STOP Drug Court) saves the county approximately \$1,400 per offender and results in reduced arrests (NPC Research 2003).

Program Description

The STOP Drug Court is for adults charged with various drug-related offenses. The Multnomah County's Drug Court is one of the oldest of its kind and reflects collaboration among criminal justice partners to quickly bring those charged with drugrelated crimes to the court system and offer opportunity for drug treatment. This offer is for outpatient treatment, one portion of the STOP Drug Court. Approximately 450 drug offenders each year participate in outpatient treatment. Those who successfully complete treatment and the conditions of the court are not convicted of their charge. The treatment program works closely with the court to provide mental health and drug treatment, employment resources, housing referrals, mentoring, and long-term follow-up services. Offenders may go to court once a week during the first phases of their recovery from addiction, decreasing to one time per month as they stabilize. Beginning this year, all people in the Drug Court also receive standard conditions of probation supervision but are not actively supervised by a probation officer. Instead, the Stop Court judge closely monitors each person's compliance with treatment and criminal behavior.

Program Justification

There is a well-researched link between drug and alcohol abuse and criminal behavior. Knight (2002) indicated that 66% of all offenders arrested test positive for illegal drugs. The Drug Court is one part of the continuum of treatment that contributes to an effective Public Safety system. This program provides an opportunity for people charged with illegal drug offenses to get treatment, be held accountable, and be diverted from further crime and incarceration. This program directly links to Safety priorities by providing drug treatment assistance, collaborating with public and community agencies to use county resources wisely, and holding people accountable for their actions. Independent studies show drug diversion (STOP Drug Court) saves the county approximately \$1,400 per offender and results in reduced arrests (NPC Research 2003).
