**Executive Summary**

The Adult Recognizance (Recog) Unit performs functions critical to the effective operation of our local criminal justice system by assisting the courts in making prompt and fair jail release decisions immediately following a defendant's arrest. Defendants are booked at the jail and then released to the community on their own recognizance. Recog staff work closely with police, parole/probation officers (PPOs), and Sheriff's Office jail staff in making release decisions. During 2005, staff conducted close to 16,500 interviews, releasing over 5,000 defendants. Nearly 80% appeared in court for their arraignment. Arraignment by law occurs within 24 hours of a jail booking; releasing the lowest risk defendants on their own recognizance averts an estimated \$550,000 in potential jail bed costs.

**Program Description**

The Recog Unit staffs the jail 24 hours, 7 days per week. Staff interview all defendants in jail with a pending Multnomah County charge. They obtain specific information before deciding whether to release someone prior to their court hearing. This minimizes unnecessary use of jail beds while protecting victims, witnesses, and the community. Recog staff work closely with police, parole/probation officers (PPOs), and Sheriff's Office jail staff in making release decisions. A pre-trial risk assessment tool is used to determine which offenders would benefit from release without sacrificing community safety.

**Program Justification**

This system provides a method of sorting offenders in a manner that results in community safety coupled with reduced costs, saving valuable jail beds for serious offenders. Recog staff provide an important 24-7 link between police officers and parole and probation officers by coordinating the process of holding violators in jail.

**Legal/Contractual Obligation**

Pretrial Release Services became statutory under Oregon Revised Statutes, 135.230 and 135.260 in January 1974. ORS 135.245 requires a judge to impose the least restrictive condition necessary to ensure a defendant's later court appearance and to release persons in custody on their own recognizance unless conditions indicate such release is unwarranted.
