#### **Executive Summary**

This program provides for the participation of the Sheriff's Office in the East Metro Gang Enforcement Team.

#### **Program Description**

MCSO participates in the East County Gang Enforcement Team (GET). The GET investigates possible gang-related violence and provides expertise in gang issues and collaborates with neighborhoods to identify issues and solve problems.

The deputy on the GET responds to any case or dispatched call involving a gang east of 162nd Ave., collaborating with TriMet, Portland Police Bureau, School Resource Officers, Troutdale, Fairview, and Gresham. The GET uses tools such as plain clothes and traffic and subject stops to identify gang members and get intelligence. Presentations are made in high schools and middle schools. The GET works with the Oregon Department of Justice to document members.

### **Program Justification**

The Local Public Safety Coordinating Council of Multnomah County reports that gang violence in East Multnomah County has steadily increased since 2000. Although hard data on numbers of youth involved is not available, both police and social service staff report that gang membership in the area is increasing.

The Gresham/East County Plan incorporates strategies to prevent and reduce gang violence.

Data from the East County Gang Enforcement Team is entered into a Oregon Department of Justice database to document gang members.
