#### **Executive Summary**

Assessment and Taxation (A&T) Business Applications Systems Enhancements supports the variety of business applications used by the linked programs of the A&T Division. Responsibilities include completing application system functionality for property appraisal, tax collection, document recording, and Internet-based information availability for public inquiry and e-business. This completes the work defined in the existing contract started in FY 2006.

#### **Program Description**

A&T Business Applications Systems Enhancements provides additional functionality to be developed by the software vendor for the business application systems used by A&T included in the existing contract referenced below. The contract defines fourteen deliverables, including creating County web pages that provide assessment and tax information that can be accessed by the public. Seven contract deliverables are expected to be completed by the end of FY 2006. The remaining seven items are expected to be completed during FY 2007.

#### **Program Justification**

A&T Business Applications Systems Enhancements contributes to the Accountability Priority by linking to all A&T Division programs and their contributions to Accountability. The program is responsible for completing the functionality of the business application systems currently used for mandated A&T business functions. Two of the contract deliverables will increase the public's understanding of and access to property tax records and support the County's initiative in e-business by providing Internet access to property tax records. The deliverables contained in this contract will provide the needed functionality for appraisal and taxation to improve the efficiency of their revenue producing operations.
