#### **Executive Summary**

The Capital Improvement Program extends the life of County buildings and optimizes the performance of building systems. This program offer will fund projects that will be cut due to holding steady the CIP fee charged to Tier 2 and 3 buildings for FY'07.

#### **Program Description**

This is a supplemental Capital Improvement Program request for a one time program offer to fill the gap between planned Capital Improvement Program rate increase and holding the rate steady for one more year in FY'07. The request is for the differential of \$595,000.

Yeon Boiler Hot Water Generation needs to be replaced.

There has been no significant dollars expended on interior finishes in tier 2 and 3 buildings over the last several years. This program offer is intended to take care of some of the worst parts of our buildings and keep us from falling even further behind in this area.

### **Program Justification**

This program offer will allow the Capital Improvement program to fulfill a FY'07 need for project funding. If not funded, the projects listed in this program offer will negatively impact the Capital Improvement program and could potentially put a building system at risk for failure impacting the operating programs within these facilities.

The Yeon boiler project will also save on-going operational dollars by reducing the amount of maintenance needed to maintain the existing boiler as compared to a new boiler.

The interior finishes also affect employee morale, and public perception of our facilities.
