Executive Summary

This program offer enhances the disaster recovery option 1, to provide a medium level of Disaster Recovery (DR) protection by establishing a dedicated location with the network and core systems already installed. With the purchase of this option you should also purchase #72073A (Disaster Recovery Option #1). This option will significantly reduce the recovery time of the County's business applications in the event of a disaster and will ensure that data will be no older than 3 days.

Program Description

This increased level of disaster recovery (DR) protection will ensure that the data when back online, will be no older that 3 days from the time of the event. This level will also ensure the systems will be available within 7-14 days of the disaster. The disaster recovery plan will be reviewed and tested on an annual basis. This option provides Wide Area Network access to the disaster recovery site from internal business locations and Internet access for external partners.

Program Justification

The Disaster Recovery program provides a plan and budget to reduce the risk of IT resource loss during a major event where the current Data Center assets are destroyed. This option provides medium level of Disaster Recovery protection by establishing a dedicated location with the network and core systems installed. This program option will meet the compliance requirements for the Health Insurance Portability and Accountability Act (HIPAA) and the Criminal Justice Information Systems (CJIS) Security Policy. This program promotes the perception of trust and confidence by citizens that County government is taking steps to ensure the availability of County services in the event of a disaster.

Performance Measure - Description

At this level of disaster recovery we will measure our performance by conducting one plan review and test per year. The test will be a mock disaster. The Outcome measures for this level of recovery suggests 7 to 14 days to recover (RTO) with a recovery point of 3 days (RPO) which is the point in time before the disaster that data and configurations were valid. RTO = Recovery Time Objective, the time to recover all mission critical data.

RPO = Recovery Point Objective, the number of days prior to the disaster that data is valid.
