**Executive Summary**

Commissioner Jeff Cogen is one of five elected members that comprise the governing body for Multnomah County. Commissioner Cogen represents the citizens of District 2, which includes North and Northeast Portland.

**Program Description**

Commissioner Jeff Cogen and his staff are working to improve the health, safety and economic well-being of individuals and families within Multnomah County. Commissioner Cogen and his staff plan to develop and advocate for practical, cost-effective avenues to community improvement. District 2 will develop an outreach plan to ensure that the needs and wants of the residents of North and Northeast Portland are reflected in the policies and initiatives developed by Commissioner Cogen and staff.

**Program Justification**

Commissioner Cogen was elected by the people of District 2 and he is ultimately accountable to them. In order to foster trust and build the relationship between Multnomah County and the residents of North and Northeast Portland, Commissioner Cogen has assembled a team of individuals experienced in community building and outreach. Each staff member will be assigned to represent and advocate for one of three district areas of District 2: North Portland, Inner Northeast and Outer Northeast Portland. These staffers will be responsible for communicating current County initiatives and programs to the community AND for bringing information back to the county from residents.
