Executive Summary

Commissioner Roberts believes public safety is the number one issue for Multnomah County residents and effective law enforcement and jail facilities give the county the flexibility to move forward with its social agenda. If citizens do not feel safe they can't be expected to support critical social issues such as transportation, education, health care, senior services and affordable housing.

Program Description

Commissioner Roberts continues his elected position, representing the citizen of East Multnomah County which encompasses the area between 148th Street to the Bonnaville Dam. This is home to over 165,000 citizens, four cities, four of the eight Multnomah County School Districts, and over 5,000 small businesses in East County.

In representing East County, Commissioner Roberts focuses on the strong work ethic of his citizenry as well as their independent mind set. He believes folks in East County want their politicians to focus on basic services that affect the most people.

Program Justification

Commissioner Roberts strives for equitable funding, whether it be locally for all schools in East County or at a state level for Community Corrections.

He has worked tirelessly to make sure his constituents get the same quality of service as the City of Portland and more urban areas receive. This is exemplified by his work toward an East County Justice Center which is moving forward once again. This project will ensure a stronger police presence in East County as well as provide a 'one-stop shop' facility for people with court issues, custody debates, hand gun licensing and a wide range of other services, without making folks drive to downtown Portland to get their business done. This project will also stimulate business growth and economic development in East County.

The third measure focuses on the Economic Growth to the Rockwood area after the Justice Center is up and running. Developers and bankers in the area have estimated upwards of 20% increase in the housing market once there is a handle on the crime in the area.

The final measure focuses the attention to the collaborative effort of the East County Justice Center. This building will combine Courts, DA, MCSO, and Gresham PD. There are future opportunities, once the building is operational as well as during the construction phase; such as educational training, internships and apprenticeships, artistic community outreach, low income housing, etc.
