Executive Summary

A community of involved citizens is fundamental to building trust and accountability in County government. This offer provides the resources for the Citizen Involvement Committee through, its office, to energetically pursue this goal.

Program Description

This offer 1) opens the Office of Citizen Involvement during regular business hours;2) provides citizens and the county with a single common site for volunteer information and opportunities as called for by Auditor Flynn, the Citizen Participation Assessment and the Citizen Involvement Task Force Report; 3) provides reception and clerical support to citizens and the Director of the Office;4) shortens the processing time for citizen requests and recommendations; 5) removes existing and perceived barriers through the use of a variety of communication tools; 6) frees up the Director to a) take discussions to communities that currently do not participate in county government, b) recruit, sustain, and keep engaged current volunteers, c) provide enhanced support and direction to the Citizen Budget Advisory Program, d) build a mutual support network between and among citizens and county staff, e) provide orientation for citizen volunteers to foster and deepen their understanding of the structure and process of county government.

Program Justification

This offer supports county accountability and transparency strategies in multiple ways: 1) by retaining and expanding the county's community of citizens who are actively engaged in its government; 2) by enhancing the publics awareness of what the county is doing while providing for and facilitating additional avenues for citizens to contribute to program development and direction; 3) by focusing efforts on seeking out and engaging the habitually disengaged; 4) by providing enhanced support to those already engaged in county government; 5) by providing a single entry point for citizens to access county government and volunteer information; 6) by allowing for regular updates to the CIC Website & publications.
