### **Executive Summary**

Additional County General Fund for Medicaid match of \$120,000 needed to maintain services at current levels due to 1) Federal officials lowered the Medicaid match rate from 45/55 to 46/54 decreasing the federal share/revenue and 2) inflationary increases for expenditures. The offer purchases 2.0 FTE Community Health Nurse positions that provide direct services for clients in need of professional nursing expertise to ensure appropriate care planning to address complex care needs. The offer also includes a .50 FTE Eligibility Specialist position to assist clients eligible for the benefits under the Medicare Modernization Act (MMA) to make decisions about the most appropriate and cost effective drug plan. This purchase will retain staffing at the current level.

#### **Program Description**

These positions provide direct services to seniors and people with disabilities by providing: Nursing expertise: 1) Screens clients to ensure need for nursing home level of care 2) Assesses new applicants with multiple diagnosis and/or indicators of mental illness or developmental disability. 3) Consults on complex cases, links with medical experts and provides professional guidance on community care plans.

Medicare Prescription Benefits Counseling: 1) Provides expertise and up-to-date information about MMA Program changes including plan and formulary changes, and system issues affecting benefit access 1) Offers clients plan options based on insurance status, prescription drug needs, and out-of-pocket expenses 2) Collaborates with state staff, pharmacies and insurance plans to resolve issues affecting clients' ability to access their prescriptions.

#### **Program Justification**

This program links to the Poverty Framework, the 10-year Plan to End Homelessness, and two Basic Living Needs Priority Strategies including 1)educating individuals about the availability and use of existing resources such as Medicare Part D and 2)preventing people from entering into more costly care including increased access to medications and early diagnosis and intervention.

This offer is needed to retain the professional nursing component of our Long Term Care system as well as maintain our current level of staffing dedicated to the responsibilities the county assumed with the implementation of the Medicare Modernization Act. Nursing capacity, as an integral part of the Aging and Disability Services case management system, allows ADS to provide a level of service consistent with the complex medical and psychiatric needs of clients. Without this purchase we will not have medical professional expertise for nursing home screenings and the comprehensive assessments and care planning necessary to fully address client needs, as well as ensure access to the appropriate Medicaid service (Aging and Disability, Mental Health and Addiction, or Developmental Disabilities Services).

The loss of the Eligibility Specialist position will reduce our ability to meet the level of need and ensure that clients are able to obtain their MMA benefit and receive their prescriptions in a timely manner.

In addition, the need to reassign this work will diminish the quality and timeliness of the case management services we provide by increasing the workloads of existing case managers.

This additional County General Fund is included in this scaled offer to supplement the 25023A ADS Long Term Care. This offer includes the following positions: .50 FTE Medicare Prescription Drug program Eligibility Specialist and 2.0 FTE Community Health Nurses.
