### **Executive Summary**

This Program provides rapid addiction assessment services for adult offenders on probation and parole by placing a Alcohol/Drug Assessment specialist in probation offices. This interdepartmental cooperation enhances the ability of Department of Community Justice staff to meet the addictions treatment needs of their clients, gets the offenders into treatment earlier and thus enhances their ability to be successful in supervision.

### **Program Description**

The Alcohol and Drug Evaluation Specialist (ADES) provides approximately 960 assessments and referral services each year for adult offenders on parole or probation. The services are located in the probation offices. The Addictions staff works closely with the Parole and Probation staff to provide client assessments, treatment referrals, clinical consultation, and other support. The ADES provides a level of expertise in Alcohol & Drug issues.

## **Program Justification**

The program links directly to Safety Priority Guidlines by facilitating criminal justice clients getting into drug/alchohol treatment in a timely manner, with screening and treatment referrals. Treatment completion greatly reduces the risk of re-offending in criminal acts and adds to the overall safety of our citizens.

This Program also demonstrates how system components (Department of County Human Services Alcohol & Drug Evaluation Specialists and Department of Community Justice Parole Officers) can work together, providing a collaborative approach that benefits service delivery by enhancing the effectiveness of Department of Community Justice supervision of offenders by increasing the likelihood of offenders entering treatment for alcohol and drug issues.
