Program Characteristics: Joint Offer

Executive Summary

Bienestar de La Familia (Well-being of the Family) is a multi-disciplinary approach serving the Latino community in Multnomah County. The program provides culturally specific and linguistically appropriate health, mental health, drug and alcohol, case management and domestic violence services to 1,711 children, families and adults countywide. Bienestar ensures care for vulnerable members of the community. The continuum of services impacts poverty, promotes family stability and assists families to meet basic living needs. Over 67% of children and families served are uninsured.

Program Description

The multi-disciplinary team includes: Mental health services (MHC)sited in La Clinica, Head Starts and CARES NW; La Clínica de Buena Salud (Primary, preventive and urgent health care); Alcohol and Drug Evaluation; Family Intervention and Resource Referral. Services include individual, family and group mental health and addiction services, prevention and early intervention services, consultation, crisis intervention, case management, food, stable housing, energy assistance, employment, clothing and information/referral. These culturally specific services are provided across the county in families' homes, schools and other locations. This is the anchor health care program for Multnomah County's homeless children and families. This past year all services have expanded to the growing Asian, Somali immigrants and Russian speaking families in the Cully neighborhood. Bienestar strives to eliminate health disparities by providing services to marginalized minority populations.

Program Justification

This program supports many of the basic living needs priorities. The offer links closely with the Policy Framework for Cultural Competency, School Aged- Policy and Early Childhood Framework. Bienestar provides interventions and coordination of services that meet basic needs thus directly connecting to the Basic Living Needs priority. 80% of mental health clients served were not insured and 60% of primary health care patients. This program consults and coordinates with other providers to build cultural competency in the community. In an effort to eliminate health and service disparities, Bienestar provides appropriate and coordinated care for Hispanic clients and families unable to access traditional services. This program provides care to vulnerable families and individuals who have little or no access to medical, mental health, alcohol and drug and social support services. Staff reflect the diversity of the community they serve. 2004 census states Hispanic population is 9.3% in Multnomah County.
