Executive Summary

The High-Risk Prenatal program provides home visits and classes to 2500 mothers and babies. Services begin in early pregnancy & continue through infancy to assure optimal maternal and infant health and assist parents in meeting their infant's basic health & developmental needs. Program Offer 40013B is based on the assumption that 40013A is in place.

Program Description

Home visits by nurses & health workers focus on prevention, risk reduction, early screening, & linkage to resources (housing, food assistance, healthcare, etc.). Priority clients include teens; women with prior newborn health problems; African-American women (historical birth outcome disparities); and women with medical conditions, domestic violence, or alcohol/drug use. Services include:

- prenatal & health education: pregnancy discomforts, prenatal care, signs of premature labor, childbirth, not smoking/drinking/using drugs, infant growth and development, back sleeping, safety, parenting, etc.
- screening for health risks: hypertension, gestational diabetes, substance use, domestic violence
- nutrition education: prenatal diet, vitamins, infant feeding
- breastfeeding assistance: preparation, techniques, support, & linkage with community resources. infant screening for growth and development

Program Justification

Readiness to learn is best ensured if children are born healthy, have parents prepared to support their growth & development, & where infants and toddlers have experiences that promote healthy child development. This offer supports Strategies 1 & 2 of the Education Team.

Basic needs of children are met by providing direct services to impact their physical and mental health & linking to community resources to meet their food, housing, and other basic needs. Providing parents appropriate health and development education prepares & supports parents' abilities to meet their child's needs. The program's first priority is reducing the risk of poor pregnancy outcomes, thus reducing the number of County infants born prematurely, at low birth weight, or with health problems or other conditions that interfere with their ability to begin learning in kindergarten.
