# **Executive Summary**

The Community Health Council (CHC) is a community-based planning body that facilitates community involvement in quality assurance, public policy advocacy, and management accountability for the Health Department. The Coalition of Community Health Clinics and its 14 member clinics continue to play an instrumental role in serving individuals who are un/underinsured in Multnomah County. The Multnomah County Health Department's indemnification program screens and indemnifies volunteer health professionals for Coalition clinics.

# **Program Description**

The Community Health Council (CHC) serves as the Health Department's community advisory board, offering an entry point for residents across the county to give input about how the County can better meet the health needs of the community. The Council acts as the Department's Citizen Budget Advisory Committee, required by County Charter. The Coalition of Community Health Clinics provides coordination, collaboration and synergy of resources between 14 independent non-profit clinics. In 2005-06, Coalition clinics provided care to over 181,000 individuals – a 68% increase from 2004-05. The MCHD health care professional indemnification program partners with the Coalition to provide qualified volunteer medical professionals to member clinics.

### **Program Justification**

The Council plays a critical role in assuring access to health care for our most vulnerable residents; and serves as the governing board required by the federal Bureau of Primary Health Care to provide oversight of policies and programs within the scope of the Primary Care Grant. 55% of Council members are county residents who use MCHD's clinical services, participation on the Council allows them to better understand and influence how the County works. The CHC's role as the Citizen Budget Advisory Committee is mandated by County Charter. Funding for the Council has leveraged millions of dollars of local, state, and federal revenue for the County, increasing access to services for vulnerable populations. County funding for Coalition of Community Health Clinic's infrastructure fuels the engine that leverages community health care resources: \$466,226 in additional funds were raised by the Coalition in 2006. The County Health Department's indemnification program for volunteer health care professionals leveraged 22,283 coalition clinic volunteer hours with an estimated dollar value of \$810,000 in 2005-2006. The County's support of the Coalition infrastructure and the MCHD indemnification program assures access to clinical care for many County residents lacking the financial resources to meet their health needs. The CHC and the Coalition contribute to outcomes in the poverty framework by leveraging citizen and community engagement in health care advocacy, decision making and provision of services for vulnerable county citizens.
