Executive Summary

Supports environmental health programs through community organizing, outreach and education. Efforts address environmental health related disparities, specifically health issues exacerbated by negative and disparate exposure to environmental, social and economic factors. Provides critical proactive and rapid response to emerging health threats like West Nile and Hanta viruses. Current work in this area has received three national awards.

Program Description

By focusing assessment, education and outreach activities on vulnerable populations, our efforts contribute to improved equity in health outcomes. By responding to emerging public health issues, our efforts prevent chronic and communicable diseases. Priorities include: preventing food and water borne illness, preventing chronic and communicable diseases (e.g., asthma, West Nile virus), reducing home environmental hazards, and supporting community input through advisory boards. An additional priority is to expand the award winning internship program developed to attract students into the environmental health workforce. Current focus is on college students with planned expansion to K-12. Grant supports include: 1) Center for Disease Control Essential Services capacity building three-year grant, building capacity to conduct better food and vector surveillance, provide environmental health community education and outreach in a culturally competent manner; 2) Housing and Urban Development Healthy Home grant is a three-year grant supporting Multnomah County Health Clinic clients by providing interventions to reduce asthma triggers in families who have children diagnosed with asthma. Multnomah County Healthy Homes is a nationally recognized performance model.

Program Justification

The program supports the Basic Needs strategy of disease prevention by identifying risks and improving environmental health with a focus on overcoming health disparities. These efforts bridge gaps identified by the community as underresourced public health issues (indoor air quality, affordable housing, lead, community education). The program has successfully leveraged additional state and federal grant resources.
