# **Executive Summary**

This program promotes community emergency preparedness. It prepares county staff to act as bridges between County Emergency Management and vulnerable communities, schools, and businesses, conduct pre-emergency outreach, develop business continuity plans, address community needs in plans and exercises, and establish agreements with individuals and organizations to assure emergency support services. This is a joint offer between the Departments of Health, Community Justice, and County Human Services.

# **Program Description**

The devastation of Hurricane Katrina severely impacted New Orleans residents who share the demographics of Multnomah County clients including the frail elderly, mentally ill, homeless, immune compromised, people with disabilities, economically disadvantaged households, individuals on parole/probation, and racially/ethnically defined communities. This program offer will engage county staff from three departments to serve as bridges between the community and the Incident Command System. Staff will earn certification in the National Incident Management System and will develop response plans for local large-scale emergencies and health threats such as pandemic flu. They will exercise their roles and responsibilities as two-way communicators between the response organization and the community in periodic small and large-scale emergency preparedness exercises. With training, they will conduct outreach with vulnerable populations, school districts, small and medium businesses, community organizations, and the broader community. They will implement presentations, public information campaigns, and web-based communication strategies. They will maintain a voluntary registry of seniors and persons with disabilities, as well as enroll into the Health Reserve Corps (HRC) licensed health care and mental health providers whom the County will call on to provide services to the community during and after an emergency.

## **Program Justification**

In a large emergency, it is important that Multnomah County be able to protect all of its residents. This requires communications that are accessible to all of our diverse communities, trusting relationships with disenfranchised populations, response plans that account for the additional needs of vulnerable populations, and continued development of relationships with businesses, schools, with other jurisdictions, county emergency management, and community partners such as 211. This program offer deepens emergency preparedness efforts by utilizing the unique skills and knowledge of county employees who are members of or significantly connected to vulnerable communities.

## **Legal/Contractual Obligation**

PL 109-365 amending Sec 306 42USC 3026, ADS is required to detail its plan to develop long-range emergency preparedness plans, with local and State emergency response agencies, relief organizations, and any other institutions responsible for disaster relief service delivery. OAR 411-055-0081 "Physical environment ... in Residential Facilities" requires an emergency procedure, evacuation plan and disaster plan for all residential facilities monitored by ADS. Multnomah County is required to develop and implement a plan to engage community stakeholders in pandemic influenza planning; this requirement is included in the Oregon Public Health Emergency Preparedness and Communicable Disease Response Program.
