Executive Summary

This new program will test inmates for controlled substances and interview inmates regarding their drug and alcohol use. Data will be collected similar to the Arrestee Drug Abuse Monitoring (ADAM) program that the National Institute of Justice administered until 2003. Funds up to \$100,000 are requested for a professional contract.

Program Description

The Drug and Alcohol Testing for Inmates program will have a professional contractor collect data on inmate drug and alcohol use. The contractor will establish a sampling methodology, develop a survey questionnaire, set up substance abuse screening and testing services, perform field work, create data sets, report on program results, and train Sheriff's Office staff in accessing and using the data. The contractor must be certified under the Clinical Laboratory Improvement Amendments of 1988.

Data collected by this program will be useful to public safety partners such as Mental Health and Addiction services, Community Justice, and the District Attorney's Office.

Program Justification

Sheriff's Office Corrections Division currently has no ability to definitively and objectively determine if an arrestee booked into jail has been using illegal drugs or alcohol. This information is important in knowing how to interact with the arrestee and in deciding on housing and treatment options.

Inmate drug and alcohol use information will also assist in providing a picture of the influence controlled substances have in crimes committed in Multnomah County. A study published in the May 2004 issue of the British Medical Journal concluded that people who misuse alcohol and other drugs are responsible for about 25% of all violent crimes. Understanding the relationship between illegal drugs and alcohol and crime may lead to strategies to address this issue more systematically.

Methamphetamine use has been a significant issue in Multnomah County. It is often associated with criminal activity. The Sheriff's Office does not have the ability to track the types of drugs used by arrestees that are booked into jail. Having this information would provide an understanding as to the far-reaching effects methamphetamines have in the criminal justice system.
