### **Executive Summary**

NOTE: This program offer should be purchased if Program Offer 60023 A thru D: Wapato Jail is not purchased.

This program offer provides funding to properly maintain the building if no corrections programs (60023 A thru D) are funded for Wapato Jail.

### **Program Description**

This program offer addresses those costs that are incurred by the County for maintaining the vacant Wapato Jail even though it would not operate during FY 2008.

Facilities & Property Management has calculated the FY 2008 operating costs for the vacant jail that include on-going routine maintenance as well as inspection, utilities, landscaping and security costs.

This program offer should not be purchased if any or all program offers 60023A thru D are funded, that would then open a portion or all Wapato jail beds. In the event of a portion or entire jail would open, the associated facility charges would be included in program offers 60023A thru D.

#### **Program Justification**

This offer reimburses County Facilities and Property Management for the maintenance and upkeep of the new Wapato Jail in an unoccupied status. These costs occur whether the jail operates or sits idle. Funding this offer contributes to properly maintaining the existing asset, keeping it safe for eventual use by programs, and ensuring that the mechanical systems operate at a minimal level to prevent premature failure of individual components.
