Executive Summary

This program offer is will place one detective within the existing Multhomah County Child Abuse Team and work with the Regional Child Exploitation Task Force and Internet Crimes Against Children. The detective will investigate, identify and apprehend sexual predators who exploit children through the Internet. The detective will also sponsor community education efforts regarding the prevention of Internet crimes against children.

Program Description

The purpose of this program offer is to facilitate a coordinated effort between the Immigration Customs Enforcement (ICE), Department of Justice with the Internet Crimes Against Children Task Force, National Center for Missing and Exploited Children, Portland Police Bureau, District Attorney's Office and other agencies participating in a Child Exploitation Task Force. This investigator will develop criminal cases against suspects who commit Internet sex related crimes against children. Investigations will include "cyber-stings" to capture suspects, develop information leading to further arrests, search warrants, computer forensic examinations, and identify sexual predators. This investigator will work collaboratively with current multidisciplinary Child Abuse Team detectives.

Program Justification

Internet crimes against children are a growing problem in our community. Experts estimate that 1-in-5 girls and 1-in-10 boys in the United States are sexually exploited before they reach adulthood. They estimate that 1 in 5 children have been solicited sexually on the Internet. These victims are left with permanent psychological, physical, and emotional scars. Several U.S. laws safeguard youth from sexual predators, including the PROTECT Act of 2003 and Adam Walsh Child Protection and Safety Act of 2006. MCSO has recently led the first successful "cyber sting" in Multnomah County and has certified three deputies through ICE's online-chatting program. The Multnomah County Child Abuse Team does not currently investigate the exploitation of children through the Internet.
