## **Executive Summary**

Traffic Safety Unit is a multidisciplinary group tasked with response to traffic complaints (the biggest single problem area as given to us by citizens), enforcement of traffic laws; criminal investigation and reconstruction of fatal and serious injury (potentially fatal)accidents; enforcement, education, and prevention in DUII; enforcement, education, and prevention of traffic complaints within school zones. Agencies in Multnomah County use this unit when cause and contributing factors to traffic related problems need investigation.

## **Program Description**

Activities include: investigations of traffic related problems as reported by citizens and business concerns in the community, providing traffic coverage to the Sheriff's Patrol Service Area, support and enforce all traffic related programs. This unit also enforces programs for child safety seat belts, DUII patrol coverage, and pedestrian safety enforcement. Educational courses are provided to the schools and community by this unit. They also conduct assistance programs to community groups, to develop programs to enhance traffic safety in the community. This unit brings trained HazMat members for the protection and preparedness of our roadways and communities regarding environmental hazards and threats to commerce. The Sheriff's Office will continue to sponsor driver education classes for Spanish speakers in partnership with El Programa Hispano of Catholic Charities. Students attend a series of classes and then take a DMV accepted written test leading to ability to take the driver portion and ultimately gain an Oregon Driver's license.

#### **Program Justification**

This program supports several aspects of the Safety Priority by identifying and understanding the community's priorities and responding; collaborating and sharing information with partners in the community and public safety system. This team participates in community based problem-solving regarding any traffic related problem through enhanced education courses. Due to the expertise of the unit, it receives funding from grant sources to support many of the counties traffic related concerns. Of this, grants for education, saturation patrolling, seat-belts, work zones, etc., are given to this unit annually. The sole purpose of this unit is to meet the concerns raised by the community they serve.
