Executive Summary

A grant has been submitted to the BJA under the Prison Rape Elimination Act (PREA) for \$350,000 to install and implement a radio frequency identification system (RFID) in 3 of the 5 housing floors in MCDC (see program offer 60051A). This program offer for \$700,000 will provide alternative funding in the event the grant is not awarded. RFID is a new and innovative technology to create a safer facility for both inmate supervision and staff safety.

Due to the timing of the grant award the MCSO will not know in sufficient time which program offer should be considered. Therefore, as soon as the grant award is known the appropriate program offer will be withdrawn.

Program Description

MCSO is committed to providing safe, cost effective offender management through implementing innovative technology that will enhance traditional supervisory techniques of inmate supervision. The protection of both staff and inmates from assaultive behavior is a high priority in any corrections institution. An RFID tracking system is a new technology to industry that will greatly increase the supervision and safety in our facilities.

While our documented sexual assaults are very low, according to the National Institute of Corrections, sexual predators in prisons and jails rely on a code of silence and incidents of sexual assault are widely believed to be under reported (Facing Prison Rape, 2004). Victims are intimidated into remaining silent and coerced into participating in activities by threats of further violence. Lack of evidence can also be a hindrance during investigations of alleged incidents and makes prosecution difficult. If offenders are routinely not punished for assaults because of lack of evidence, victims may be reluctant to report assaults. This feeds the vicious cycle of intimidation, coercion, and violence in the jails.

The presence of RFID surveillance equipment should inhibit offenders from committing sexual assault and other behavior crimes because they will know they are being recorded and documented. Proactive, intervening steps may be facilitated when the observation of suspicious activities of offenders is observed before assaultive or other behavior crimes can occur. When necessary, stronger prosecution cases will be forwarded to the District Attorney's Office which will result in an increased probability of conviction.

Program Justification

This program offer addresses the Safety priority of holding offenders responsible for their actions and apply appropriate consequences. Protecting inmates from the predatory sexual advances of other is a high priority and addresses the stream of offender populations most often associated with incarceration in a high risk jail environment.

This Program Offer also addresses the Safety priority of identifying and engaging relevant communities in defining public safety needs and developing crime prevention and protection programs. The population of a jail is a high risk community with many public safety needs. This program offer provides a means to identify and intervene in illegal behavior protecting the victim before it occurs.
