Executive Summary

The Commission is mandated by the State and County board with the creation of the 6-year plan to improve outcomes for Children and Families. Completed this year and adopted by the County Board the 6-year plan directly engaged over 300 individuals directly in determining which areas would most benefit Multnomah County children & families. Additionally, we incorporated the opinions and thoughts of, at a minimum, 20 thousand citizens through reviewing locally produced research, reports, and recommendations. 3 actions were prioritized within the plan. This program offer funds the implementation of 1 of those actions, increasing utilization of School-Based & Community-based Health Centers.

Program Description

Community Mobilization and Positive Youth Development strategies will dovetail to create this program which will hire and train 60 youth in 8 schools to create health education and marketing messages for the 9,615 youth who attend schools with School Based Health Centers. Additionally, youth outside those schools will be informed of services and may travel to a school based health center or community-based center to receive services. By mobilizing those most impacted by lack of medical care for youth, youth themselves, this program offer improves outcomes not only for those youth who access the health centers but also the 60 youth hired to create the marketing messages and peer health education materials. The Multnomah Youth Commission and the "Our Bill of Rights: Youth & Children" Implementation Committee will lead this effort to increase youth awareness and utilization of existing community health resources, including School-Based Health Centers. These materials will be distributed in schools and the community by youth, school staff, and County Health and Human Services Departments working directly with youth.

Program Justification

To be accountable to the public we need to create open, honest processes for their engagement and involvement; clearly disseminate the result of the process, and then follow through by implementating the recommendations and improving our systems so we create the best outcomes for the least amount of money possible. Without implementation our efforts around the 6-year plan become no more than more planning for planning sake. Funding this program offer increases trust and confidence in Multnomah County because the 300 citizen involved in the 6-year plan see that we follow through. Funding this program offer increases satisfaction with government services, effectiveness and price by improving the health of our young people while also ensuring that current investments (School Based Health Centers & School Based Mental Health) are fully utilized and serving as many youth as possible. Additionally, a side benefit is that this effort links diverse young people to local government. They will gain an understanding of how the County operates and will have access to County staff and decision-makers.

Performance Measure - Description

The 0% increased utilization of SBHC represents a stabilization of clinic usage in the face of large cuts in service hours, days, and times. If we are are to keep the same level of utilization with greatly reduced resources this will be a great accomplishment. Without this program offer, utilization of clinics by youth who need medical care is expected to drop.

ESL- English as a second language, again the low target of a 10% increase reflects on the recent reducation in clinic capacity (hours, times, staff). If we are able to increase this vulnerable population's access given current reductions in service this will be an important achievement.
