Executive Summary

This Program Offer supports the Multnomah County 2009, Climate Action Plan (CAP) which serves as the 40-year roadmap for the institutional and individual change needed to address climate change through reducing greenhouse gases and building a resilient and engaged community. The Health Department has a critical role in evaluating the potential health cobenefits and unintended health harms of climate change while advocating for carbon reduction strategies that are fair and just in their application. This program will 1) identify strategies that should be incorporated into the Multnomah County/City of Portland Climate Action Plan utilizing a population health/health equity lens, 2) establish and support Health Department program teams and the Office of Sustainability to implement the Climate Action Plan using a population health/health equity lens, 3) develop a public engagement campaign to promote carbon emission reductions and the public health co-benefits of this reduction that can be accomplished at the individual and community level and integrate this message into various existing health outreach activities.

Program Description

The Program Offer is designed to implement actionable items in the Climate Action Plan by focusing on key initiatives and programs that intersect between improving health and the environment and assuring that all people have the same opportunity for clean air, water, healthy safe food, parks and public transportation. This is a scaled offer requesting 1.0 FTE of a Program Development Specialist to accomplish the efforts. Specifically the resources requested in this offer will: 1) Further integrate health and equity co-benefits and adverse health effects into the Climate Action Plan implementation and revision. Identify further PH strategies to be integrated into the plan and identify opportunities to integrate a climate lens into health actions and messaging.

- 2) Provide support for Health Department program teams that have self-identified as having a role in Climate Action Planning; Vector Control, Communicable Disease, WIC, Environmental Health and Housing, Community Wellness Prevention, Public Health Infrastructure and Emergency Preparedness to identify how they can implement CAP at the program and community level
- 3) Provide support for other Health Department program teams to identify how they can implement the CAP at the program and community level.
- 4) Develop a community-wide public engagement campaign to promote carbon emission reductions that emphasize the multiple health, environmental and economic benefits along with ways reductions can be accomplished at the individual and community level.

Failing to address these issues will likely have disproportionate impacts on the most vulnerable populations. Extreme heat, vectors (rats and mosquitoes) and availability of potable drinking water are all examples of impacts of climate change anticipated to have a disproportionate impact on children, the elderly and low-income people. A 1.0 FTE Program Development Specialist will be required to support the four actions identified above. Only action 1 and 2 can be accomplished with .5 FTE of a Program Development Specialist. This Program Offer leverages other existing resources within MCHD. It relates to CAP specific action items: 16-1, 16-3, 17-1, 17-2, and 18-11.
